Industrial New Orders Received Indices (INORI). Base 2015 December 2019 and year 2019. Provisional data

The monthly variation of the Total Industrial New Orders Receives Index¹ stands at −0.2%, after seasonal and calendar adjustment


The annual rate stands at 1.1% in the seasonal and calendar adjusted series and at 2.7% in the original series

Throughout the year 2019, the new orders received decreased by 1.0% in the adjusted series and by 1.1% in the original series

Monthly trend of Industrial New Orders Received

The monthly variation of the seasonally and calendar adjusted Industrial New Orders Received Index between December and November stood at -0.2%. This rate was eight tenths lower than the previous month.

Industrial New Orders Received Index, Total. Seasonally and calendar adjusted Monthly rate. Percentage





By Main Industrial Groupings (MIGs), *Energy*² (9.5%) and *Durable consumer goods* (0.6%) showed positive monthly rates. On the other hand, *Non durable consumer goods* (-1.3%), *Capital goods* (-1.1%) and *Intermediate goods* (-0.3%) showed negative monthly rates.



Annual trend of Industrial New Orders Received

The Total Industrial New Orders Received Index, once adjusted for seasonal and calendar effects, showed a variation of 1.1% in December, as compared with the same month of the previous year. This rate was 21.4 points higher than the one registered in November.

The INORI original series of the registered an annual variation of 2.7%. This rate was 25.1 points higher than the one in November.

By MIGs, the seasonally and calendar adjusted indices registered positive annual rates in three of five of the analysed sectors, highlighting the increase in *Non-durable consumer goods* (6.7%).

Throughout the year 2019, the New Orders Received Index, once adjusted for seasonal and calendar effects, increased by -1.0% as compared with 2018, and by -1.1% in the original series.

negative annual rates in cuatro of five of the analysed sectors, highlighting the decrease in $Energy^2(-5.1\%)$.


Annual trend of the Industrial New Orders Received by market. Original series


Results by Autonomous Community. Annual rate of the Industrial New Orders Received. Original series

Press Release

New orders received increased as compared to December 2018 in seven Autonomous Communities and decreased in the other 10. The largest decreases were recorded in Castilla - La Mancha (-24.7%), Principado de Asturias (-14.4%) and Extremadura (-7.4%). The largest increases were recorded in Comunidad de Madrid (21.0%), Comunitat Valenciana (18.1%) and Comunidad Foral de Navarra (9.7%).

Throughout the year 2019, the new orders received increased in 10 Autonomous Communities and decreased in the other seven. The largest decreases were recorded in Región de Murcia³ (-33.2%), Castilla y León (-6.6%) and Andalucía (-4.7%). The largest increases were recorded in Comunidad Foral de Navarra (9.4%), Galicia (8.3%) and Castilla - La Mancha (7.9%).

Revisions and data update

Press Release

On the press release day, INE has updated INORI data series corresponding to the last 13 months. In the case of calendar adjusted and seasonally and calendar adjusted series, according to INE standard, series are revised since its beginning. Results are available at INEBase.

Methodological note

Industrial New Orders Received Indices (INORI) are short-term indicators aiming at measuring the monthly evolution of the industrial sector, excluding the construction.

The required information is collected since January 2002, together with the Industrial Turnover Indices (ITI) through a survey addressed to more than 12.000 industrial establishments throughout the country.

Survey Type: ongoing monthly.

Base year: 2015.

Population scope: units of economic activity whose main activity is included in Sections B: Extractive industries (with the exception, due to their not being relevant to Spanish industry, of division 09) or C: Manufacturing industry of CNAE-2009.

Geographical scope: the whole country, excluding Ceuta and Melilla.

Sample size: Approx. 12,000 establishments.

Data collection: monthly, value of total business turnover broken down by market.

Collection method: fill in a questionnaire by the respondent using one of the following methods: internet (IRIA system), email, fax, telephone or post.
